Education in Balkan Countries in the 21st Century

It is generally accepted that the study of education – especially through comparisons – nowadays judged as being particularly important, given that education is called to play an important role in modern societies considering the impacts of socio-political, ideological, demographical, cultural, economical and educational challenges of the 21st century. In this context the main challenging concern is the internal effectiveness of school (*internal efficiency*), but also its exterior effectiveness (*external efficiency*).

Education policies and reforms in different countries are considered to play a crucial role for the development of education and educational systems and their effectiveness. From this perspective, education in Balkan countries in the 21st century could be a very fruitful field of comparative studies regarding various educational and pedagogical matters.

Some main axes in relation to this issue could be proposed for discussion:

1. Recent reforms and changes in education of Balkan countries with emphasis on primary education (presentation of a *Special Issue* on the topic in Greek language).
2. Reforms and/or Perspectives in teachers training and re-training: theoretical approaches and research data (presentation of an *International Handbook on Teachers Training*).
3. Recent European educational policies concerning the Balkans (programs, mobility, etc.).
4. Educational cooperation in Balkan countries: discussion on the possibilities of exchanges, academic cooperation and common research projects.
5. Balkan countries and other European and non-European countries: educational relations, exchanges and cooperation.
6. Discussion on the project on "*Social Studies Textbooks in Balkan countries*": possibilities of realization of the project.
7. Discussion on different possibilities of cooperation and common research activities.
8. Subjects proposed by the participants of the round table: open discussion, propositions, drafts.
